CitriSan™ can be applied to all crops including fruit trees, vines, tree nuts, fruits and vegetables, field and row crops, ornamental trees, shrubs and flowers, containerized plants, and turf.

CitriSan™ IS NOT FOR AQUATIC USE.

DIRECTIONS FOR USE:

Under normal circumstances, it is recommended to use 1-2 packets per 100 gallons of water in order to reduce pH level to 5.0 or below. This suggested directive of use will vary based on components and products being mixed as well as geographical variations in water quality. Before using, mix all components according to suggested directions. Measure spray solution pH with a pH meter and then adjust using **CitriSanTM** as needed to obtain a pH of 5.0 or below. Add O2YS or Organisan products per label instructions.

Required - pH must be 5.0 or below to use O2YS and Organisan products.
